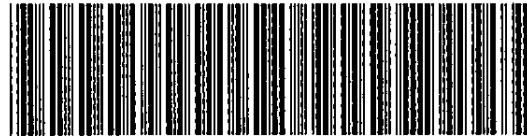

**ARTICLE I. CORPORATE NAME**

The name of this corporation is: Baywest Welding & Fabrication, Inc and the street address and mailing address of the principal office of this corporation is 1351 Wildwood Lane, Lutz, FL 33558-5276.

**ARTICLE II. NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III. CAPITAL STOCK**
