PURPOSE

The objects for which and for any of which this Corporation is formed: To engage in the performance of all types of investments including real estate, and investment counseling, as well as the supplying of materials and construction, and any other accessory and related activities pertaining thereto. To enter into, make, perform and carry out contracts of every kind and for any lawful purpose with any person, firm, association, corporation or body politic or government, for the purposes of the corporation.
