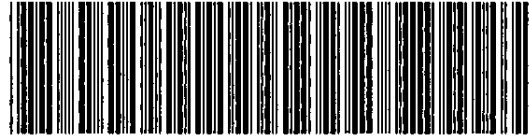

ARTICLE I. NAME

The name of this corporation is ZACK THOMAS LAWN & DETAIL, INC.

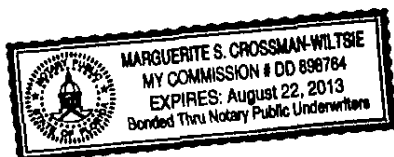
