

ARTICLE IV - SHARES

The number of initial shares of stock is: 100,000,000 (one hundred million) of common voting stock. However, the corporation reserves the right to issue additional shares of stock as may be authorized by a majority vote of the shareholders. This is without limitation to issue shares in such classes and amounts, and of such nature as allowed by law. By way of example and without limitation, the corporation may issue common stock, preferred stock, securitized stock, stock with or without voting rights, as specified, and for whatsoever purpose the corporation deems proper. Any class of stock shall be formally memorialized by a written certificate, which shall state with particularity what class of stock the certificate represents, and shall be issued in numerical order, with each shareholder entitled to said certificate signed by the President, or a Vice President, and the Secretary or Assistant Secretary, and may be sealed with the seal of the corporation or a facsimile thereof. The signatures of such officers may be facsimiles if the certificate is manually signed on behalf of the transfer agent, or registered by a registrar, other than the corporation itself or an employee of the corporation. If an officer who has signed or whose facsimile signature has been placed upon such certificate ceases to be an officer before the certificate is used, it may be issued by the corporation with the same effect as if the person were an officer on the date of issue.
