

ARTICLES OF INCORPORATION

OF

I, the undersigned, being of legal age and a natural person, do hereby subscribe to acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name and initial address of this Corporation shall be: Michael J. Bittman, P.A., 390 North Orange Avenue, Suite 1400, Orlando, Florida 3280I-4961, with the privilege of having its offices and branch offices at other places within or without the State of Florida.
