The undersigned, for the purpose of forming a corporation under the "Florida Business Corporation Act," does hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation is: **Rene's Hospitality Services Group, Inc.**

ARTICLE II

The principal place of business and mailing address of the Corporation shall be:

ARTICLE III

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE IV

The Corporation shall commence upon the filing of these Articles of Incorporation, and shall have perpetual existence.
