ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation shall be:

JOY LYNN DOYLE, P.A.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

To engage in services and activities associated with the listing and sale of real estate, both commercial and residential, as a sales associate.

To engage in any other lawful business, to purchase, or otherwise acquire, and to own, mortgage, pledge, sell, convey, assign, transfer, or otherwise dispose of, and to invest in and hold real or personal property, of every class, kind, and description, and to otherwise engage in any legat business or activity permitted under the laws of the State of Florida and in all other States and counties.
