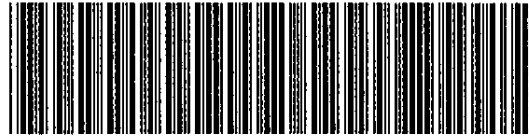

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract and legally authorized to practice the profession of law in the State of Florida, hereby forms a professional corporation in accordance with the Florida Professional Corporation Act, and hereby adopts the following:

Articles of Incorporation:

ARTICLE ONE

CORPORATE NAME AND PRINCIPAL OFFICE

The name of the corporation is E.C. Pappas, P.A., and its principal office and mailing address is 150 Eglin Parkway NE, Fort Walton Beach, Florida 32548.

ARTICLE TWO

NATURE OF BUSINESS

The purpose of the corporation and the nature of its business are to engage in the practice of law and to render such services as may be ancillary to the practice of law. The corporation may purchase and own real and personal property necessary or appropriate for rendering its professional services and may invest its funds in real estate, mortgages, stocks, bonds and any other type of investments, all in accordance with the provision of F. S. A. Chapter 621.

ARTICLE THREE

CAPITAL STOCK

The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time is 100 shares, having a par value of \$1 per share. Such shares shall be of a single class of common stock. None of the shares of the corporation may be issued to anyone other than an individual who is duly licensed to practice law in the State of Florida and is an active member of the Florida Bar in good standing.

ARTICLE FOUR

TERM OF EXISTENCE

This Corporation shall continue its existence for the maximum period allowed by Florida law.

## ARTICLE FIVE

### REGISTERED AGENT AND INITIAL REGISTERED OFFICE

The street address of the principle and initial registered office of the corporation is 150 Eglin Parkway NE, Fort Walton Beach, Florida. The registered agent is Ellen C. Pappas. The Board of Directors may from time to time move the office to any other address in the State of Florida and change the registered agent.

## ARTICLE SIX

### BOARD OF DIRECTORS

This Corporation shall be managed by a Board of Directors of at least one director. No person shall serve as a director of the corporation unless the person is duly licensed to practice law and is an active member of the Florida Bar in good standing. The directors shall be elected by the shareholders of the corporation. The name and address of the sole shareholder and the sole member of the Board of Directors and the number of shares subscribed to her is as follows:

## ARTICLE SEVEN

### RESTRAINT ON ALIENATION

No shareholder may sell or transfer her shares corporation, except to another individual who is eligible to be shareholder of the corporation under Florida law.

## ARTICLE EIGHT

### DISQUALIFICATION

Any officer, shareholder, agent or employee of the corporation who has been rendering professional services to the public for the corporation becoming legally disqualified to render such professional services within Florida or who accepts employment that places restrictions or limitations upon his or her continued rendering of such professionals services, then the corporation shall require him or her to comply with the Florida Professional Service corporation Act by severing all employment and financial interest in the corporation.


