A Professional Association

The undersigned incorporator, for the purpose of forming a professional association pursuant to the Florida Professional Service Corporation Act, hereby adopts the following Article of Incorporation:

ARTICLE 1 - NAME

The name of the Professional Association shall be: The Law Office of Christopher J. Wyszynski, P.A.

ARTICLE 2 - PURPOSE AND RESTRICTIONS

- 2.1 Purpose: The purpose for which this Professional Association is organized is to engage in all aspects of the practice of law.

ARTICLE 5 - SHARES

The Professional Association shall have the authority to issue 100 shares of common voting stock of a single class.

ARTICLE 6 - INITIAL REGISTERED OFFICE AND AGENT
