ARTICLES OF INCORPORATION OF HEALTHCARE QUALITY REVIEW, INC.

The undersigned subscriber(s) to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

ARTICLE I. - NAME

The name of this corporation is: HEALTHCARE QUALITY REVIEW, INC.

ARTICLE II. - NATURE OF BUSINESS

TO ENGAGE IN ALL ASPECTS OF THE PROFESSION.

The general nature of the business to be transacted by this corporation shall be

- a) To engage in the buying and selling of any and all types of commercial traded products, within the United States or the purchasing and sales can be a world wide activity and to engage in any and all functions, services and/or ancillary, thereto, and to do all other things which may be desirable to achieve the purposes aforesaid and to operate a successful business.
