**ARTICLES OF INCORPORATION**  
**FOR**

The undersigned acting as incorporators of a corporation under the Florida General Corporation act adopts the following Articles of Incorporation for their corporation.

**ARTICLE I**

The name of the corporation shall be ROYAL COMPLETE HOME, INC., whose principal place of business 1757 Overseas Hwy, Marathon, FL 33050, and its mailing address 1429 N. Krome Avenue, Florida City, FL 33034.

**ARTICLE II**

The period of duration of the corporation is perpetual.

**ARTICLE III**

The purpose or purposes for which the corporation is organized is for complete home renovation, including and not limited to: develop, design, deliver, install and sell home furnishings, interior design services, delivery and installation of home furnishings, appliances, floor coverings, wall coverings, lighting, window treatments and similar interior improvements and to do generally to do any and all things necessary, pertinent, or convenient to the purposes herein and hereby stated or any activity or business permitted under the laws of the United States and of this State and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all of the things incidental to them or connected with them that are not forbidden by Florida corporation Laws or by any other law, or by these Articles of Incorporation, and to carry out the said purposes in any State, Territory, District, or possession of the United States, or in any foreign country.

**ARTICLE IV**

The aggregate number of shares that the corporation shall have the authority to issue is one hundred (100) shares of capital stock with the par value of one dollar (\$1.00) per share.
