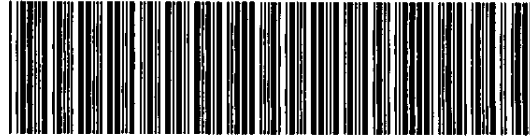

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida:

1. NAME AND ADDRESS. The name of this corporation and the mailing address of the corporation are:

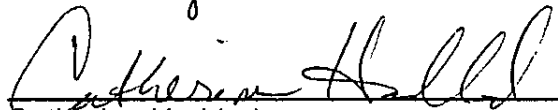

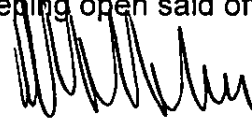
