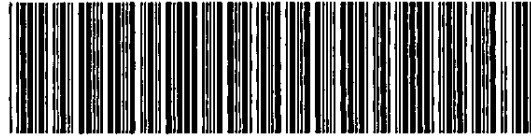

**ARTICLES OF INCORPORATION
OF
RVC SUREBOX TRADING INC.**

The undersigned incorporator, being one (1) in number for the purpose of becoming a body corporation hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be RVC SUREBOX TRADING INC. hereinafter referred to as the "Corporation." The registered office and principal place of business of this corporation shall be at 201 N New Warrington Rd., Suite 2 Pensacola, Florida 32506.

ARTICLE II: DURATION

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Secretary of State.

ARTICLE III: PURPOSE

The Corporation is organized for the purpose of engaging in the business of packaging and shipping non-perishable goods, and for the purpose of transacting any or all other lawful business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE IV: CAPITAL STOCK

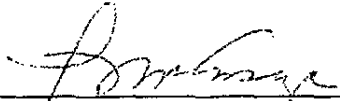
ARTICLE X: BY- LAWS

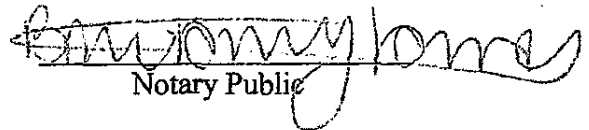
