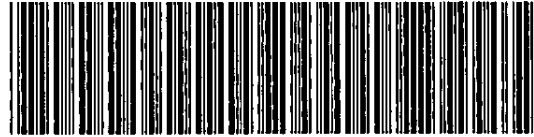

The undersigned subscriber, a natural person competent to contract, desires to submit these Articles of Incorporation for the purpose of forming a corporation in compliance with Chapter 607, *Florida Statutes*, as the same may from time to time be amended (the "Act").

**ARTICLE I  
NAME**

The name of the corporation is ICE PLANT BAR & BOTTLE SHOP, INC. (the "Corporation").

**ARTICLE II  
PRINCIPAL PLACE OF BUSINESS**

The principal place of business of the Corporation is 110 Riberia Street, St. Augustine, Florida 32084.

**ARTICLE III

**ARTICLE IV  
NATURE OF BUSINESS**

This Corporation is organized for the purpose of transacting any and all lawful business for the purposes selling goods.

Any obligation that the Corporation may issue or sell which is convertible into or exchangeable for any stock of the Corporation of any class or classes, or to which is attached or pertinent to any warrant or warrants or other instruments conferring on the holder the right to subscribe for or purchase from the Corporation any shares of its stock of any class or classes.

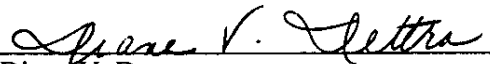

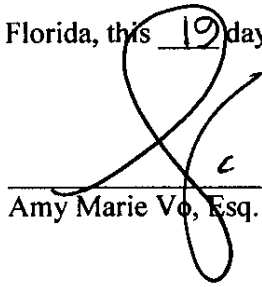
