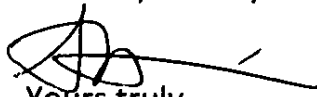

"ARTICLE 1"

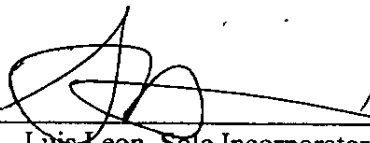

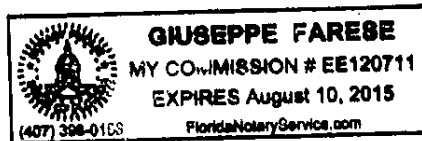

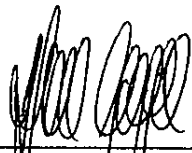
