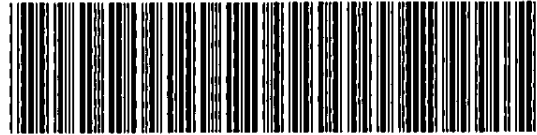

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of Incorporation.

ARTICLE I: NAME

The name of this corporation shall be A&M ATLANTIC SEAFOOD, INC.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE
