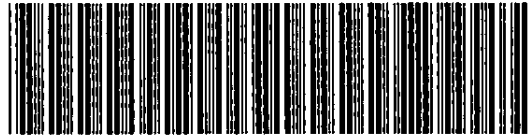

ARTICLES OF INCORPORATION  
OF  
SEAN J. TRINKLE, P.A.

The undersigned incorporation, who is licensed or otherwise legally authorized to sell real estate in the State of Florida, intends to form a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability company Act, and adopts the following articles of incorporation for the corporation.

ARTICLE ONE  
NAME

The name of the Corporation is SEAN J. TRINKLE, P.A.

ARTICLE TWO  
PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT

The street address of the initial registered office of the corporation is 911 E. Rose St., Lakeland, FL 33801, and the name of the initial registered agent at such address is Sean J. Trinkle, President. The business address is the same as the initial registered office address.

ARTICLE THREE  
DURATION

The duration of the corporation is perpetual from the date of incorporation.

ARTICLE FOUR  
PURPOSE

The general purposes for which the corporation organized are:

1. To engage in the activities of a licensed real estate professional.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FIVE  
CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 1000. Such shares shall be of a single class, and shall be without par value.

ARTICLE SIX  
CORPORATE POWERS

The corporation shall have all the rights and powers now or subsequently conferred on professional corporations by the laws of the State of Florida.

ARTICLE SEVEN  
INCORPORATOR

The incorporator of this corporation is: Sean J. Trinkle-PO Box 869, Polk City, Fl 33868.

ARTICLE EIGHT  
DIRECTORS

The number of directors constituting the initial board of directors of the corporation is one, although the corporation is authorized to have five directors. The names and addresses of the persons who are to serve as members of the board of directors are:

The initial director shall hold office until his successors are elected and qualified as provided in the by laws. Then the term of office of each director shall be one year and until the election and qualification of a successor. The number of directors set forth in these articles of incorporation and constituting the initial board of directors shall be the authorized number of directors until that number is changed by a by law duly adopted by the shareholders.

ARTICLE NINE  
BYLAWS

The initial director shall submit the proposed bylaws to the shareholder at a meeting to be held for that purpose not more than thirty days following the issuance of the Certificate of Incorporation. Following the adoption of by laws by a majority, the internal affairs of the corporation are to be regulated and managed in accordance with the by laws.

ARTICLE TEN  
DISSOLUTION

The corporation may be dissolved at any time (1) by a unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of at least two-thirds of the outstanding shares of the corporation entitled to vote. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders prorate, each shareholder to participate in the distributing in direct proportion to the number of shares held by the shareholder.

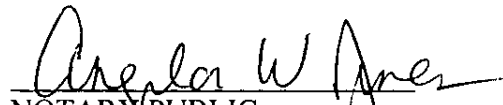

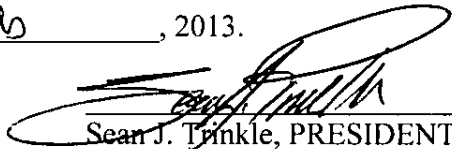
