- 1. I am over the age of 18 and competent to testify as to the matters contained herein and state such under my own personal knowledge.
- Kid E Nation Inc. was incorporated in the state of Florida through the Florida Department of State, Division of Corporations, on March 5, 2013, and its document number is P13000020817.
- 3. On May 31, 2024, a duly convened meeting of the majority of the company's Board of Directors was held, and a corporate resolution was passed removing Colette M. Robertson from all positions and titles of the company. Through this same resolution, I was appointed as President, Secretary, and Treasurer, as well as continuing to serve as a company director.
- 4. Also on May 31, 2024, a corporate resolution was also passed giving the company the authority to amend the official corporate information at the Florida Division of Corporations, and such amendment was submitted to the Florida Division of Corporations.
- On June 27, 2024, Colette M. Robertson submitted to the Florida Division of Corporations an "Affidavit of Fact," and reversed the corporate information updated on June 19, 2024, as authorized by the company's Board of Directors.
- 6. I dispute that Colette Robertson is a majority shareholder in Kid E Nation and further that she has authority to act as a majority shareholder or corporate officer of Kid E Nation.

7. On July 3, 2024, I, Stephanie C. Sorrentino, President of Kid E Nation, Inc., have submitted once again, and with the proper company authority, an amendment to correct the company information with the Florida Division of Corporations.
