**ARTICLES OF INCORPORATION
OF
ECTOVOX CONSULTING, INC.**

The undersigned incorporator hereby makes, subscribes, acknowledges and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I
Name and Address

The name of this corporation is **ECTOVOX CONSULTING, INC.**; its principal place of business and mailing address is 1000 Sweetbriar Road, Orlando, Florida 32806.

ARTICLE II
Existence of Corporation

This corporation shall begin existence on the date of filing of these Articles with the Secretary of State, Division of Corporations for the State of Florida and shall have perpetual existence.

ARTICLE III
Purposes

The corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV
Authorized Shares of Capital Stock

(a) The total number of shares of capital stock authorized to be issued by the corporation shall be 10,000 shares of common stock having a par value of \$0.01 per share. All or any part of said common stock may be paid for in cash, in property or in labor or services actually performed for the corporation and valued at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All common stock when issued shall be paid for and shall be non-assessable.

(b) Subject to the rights of any outstanding class or series of capital stock ranking senior to common stock as to dividends, dividends may be paid upon common stock in cash, property or securities as and when declared by the Board of Directors out of funds legally available therefore. As and when dividends are so declared and paid, the holders of common stock shall be entitled to participate in such dividends ratably on a per share basis. In the event of any liquidation, dissolution or winding-up of the corporation, whether voluntary or involuntary, the holders of common stock are entitled to share ratably in the net assets, if any, remaining after payment in full of all debts and liabilities of the corporation and after the holders of any outstanding class or series of capital stock ranking senior to common stock shall have been paid in full the amounts to which such holders shall be entitled, or an amount sufficient to pay the aggregate amount to which such holders are entitled shall have been set aside for the benefit of the holders of such senior capital stock.

This corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


