ARTICLES OF INCORPORATION

OF

THE PRESERVE AT LAKE FOREST GP, INC.

Pursuant to the filing of these Articles of Incorporation (these "Articlestic") the undersigned hereby forms a Florida profit corporation under The Florida Business Corporation Act, Chapter 607, Florida Statutes (the "Act").

ARTICLE I NAME

The name of the corporation is THE PRESERVE AT LAKE FOREST GP, INC. (the "Corporation").

ARTICLE II PURPOSE

The general purpose of the Corporation shall be the transaction of any and all lawful business.

ARTICLE III PRINCIPAL OFFICE AND MAILING ADDRESS
