ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME



ARTICLE 7 - CORPORATE CAPITALIZATION

- 7.1 The Maximum number of shares that this Corporation is authorized to have outstanding at any time is **ONE MILLION** (1,000,000) shares of common stock, each share having the par value of **ONE DOLLAR** (\$1.00).

ARTICLE 8 - SHAREHOLDERS' RESTRICTIVE AGREEMENT
