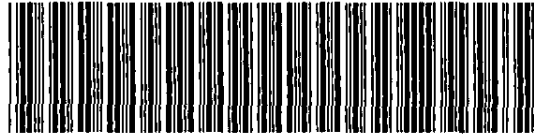

**ARTICLES OF INCORPORATION  
OF

Pursuant to Florida Statutes Section 607.0201, the undersigned hereby submits the following Articles of Incorporation of **TT OF LAKE SHORE, INC.**, a corporation being organized under the laws of the State of Florida.

**ARTICLE I.**
