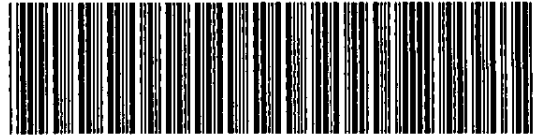



This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.


#### **ARTICLE X = INDEMNIFICATION**


