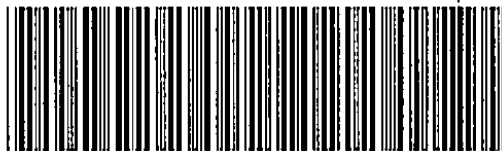

ARTICLE IV

The aggregate number of shares the corporation is authorized to issue is:

100,000

The stock of this Corporation shall be divided into two classes of common stock, voting ("Class A") common stock and non-voting ("Class B") common stock. There shall be no par value per share of common stock. The number of voting shares authorized shall be 10,000 and the number of non-voting shares authorized shall be 90,000. Except for voting rights, all shares of non-voting common stock and voting common stock shall have equal rights and preferences.
