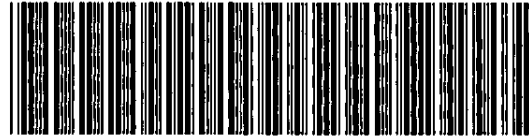

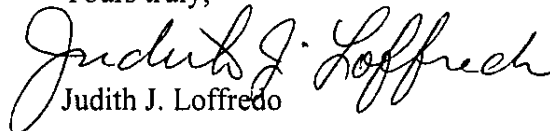

ARTICLES OF INCORPORATION

OF

ARTICLE I

The name of the Corporation ("Corporation") is Lindor Painting, Inc.

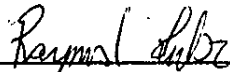

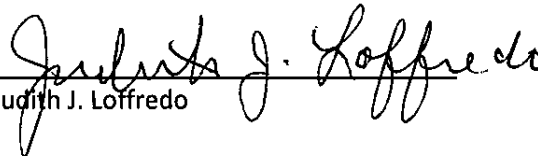
