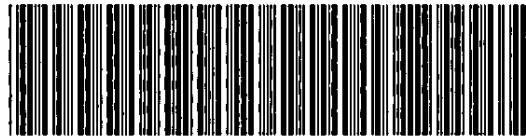

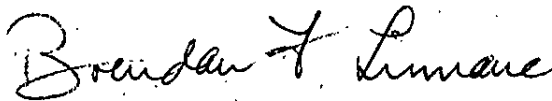

**ARTICLES OF INCORPORATION
OF FLOORMASTER ORIENTAL RUG CLEANERS, INC.**

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I: NAME

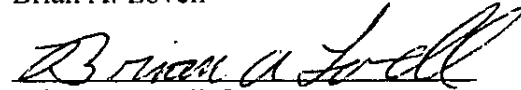
