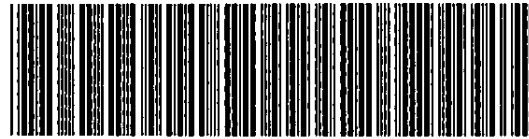

**ARTICLE I
NAME OF CORPORATION**

The name of this corporation is ONE SHOT ENT, INC.

**ARTICLE II
PURPOSE**

The purposes for which the Corporation is formed and the objects to be carried on and promoted by it are as follows:

A. This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

B. More specifically, this corporation is in the business of promoting entertainment in the form of boxing events, football games, clothing sells, and music and video productions.

**ARTICLE III
DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE IV
CAPITAL STOCK**

This corporation is authorized to issue one hundred shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares." The shares are not to be divided into classes.

**ARTICLE V
PRE-EMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rate share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

**ARTICLE VI
INITIAL BOARD OF DIRECTORS**

This corporation shall have two Directors constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time pursuant to the by-laws. The name and address of the initial Board of Directors of the corporation is:

The By-laws of the Corporation shall be adopted by the Board of Directors and may be altered, amended or rescinded in the manner provided by the By-laws.

ARTICLE X AMENDMENTS

The Corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, by a 2/3 vote of the Board of Directors, and any right conferred upon the shareholders is subject to this reservation.
