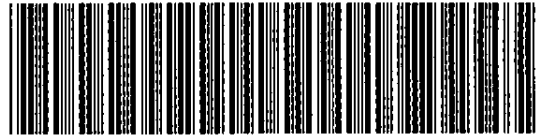

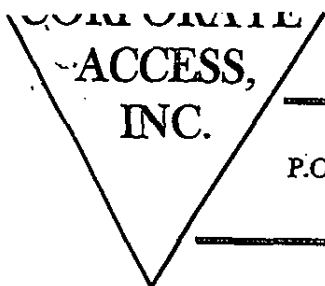

**ARTICLE I:** The name of the corporation is Indie Bar III, Inc.

**ARTICLE III:** The maximum number of shares this corporation is authorized to issue is one hundred, all of which shall be Common Shares and have a par value of \$.001 each. 
