
**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
CAREPREDICT, INC.**

CarePredict, Inc., a Florida corporation (the "Corporation"), hereby certifies, pursuant to and in accordance with Section 607.1006 of the Florida Business Corporation Act (the "Act"), for the purpose of filing its Articles of Amendment to the Articles of Incorporation (the "Amended Articles") with the Department of State of the State of Florida, that:

1. The name of the Corporation is CarePredict, Inc.
2. Article V of the Corporation's Articles of Incorporation is hereby amended and restated to read in its entirety as follows:  
  
"The number of shares the corporation is authorized to issue is 10,000,000 shares of Common Stock, par value \$0.00001 per share."
3. The amendment set forth herein was approved on January 3, 2014 by a joint written consent of the sole stockholder and sole director of the Corporation. The number of votes cast for the amendment by the sole stockholder was sufficient for approval.
4. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
