



We, the undersigned, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the Several Acts of Legislature of the State of Florida, do hereby subscribe to this partificate of incorporation.

FIRST: The name of the corporation is:

SECOND: The business of this corporation shall be to engage in any and all lawful business or businesses.
