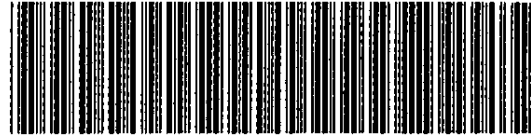

**ARTICLES OF AMENDMENT
to the
ARTICLES OF INCORPORATION**

SOCIAL PHYSICIANS NETWORK INC.
