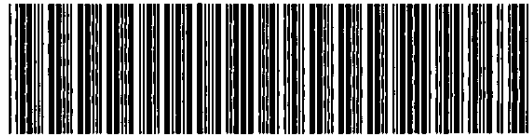

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act Chapter 607 of Florida Statutes and the Professional Service Corporations and Limited Liability Companies Act, Chapter 621 of Florida Statutes, adopts the following Articles of Incorporation for such Corporation:

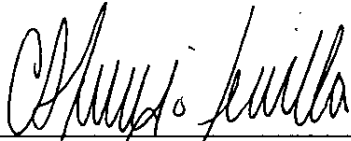

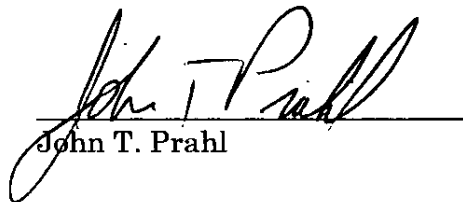
