ARTICLES OF INCORPORATION OF The LIFE Team, Inc.

In compliance with Chapter 607 and/or Chapter 621, FS

Article I Name

The name of the corporation shall be:

The LIFE Team, Inc.


Article II Principal Office

4991 Vizcaya Drive Pensacola, FL 32507

Article III Purpose

The purposes for which the corporation is organized are:

- (a) To conduct a letter writing campaign using local supporters and political action groups requesting: local, state and federal politician vote against grounding the Blue Angels and to conduct a fund-raising campaign designed to supplement current and future Naval Aviation Museum Foundation projects underway directly related to the Blue Angels.
- (b) To loan money upon such security as may be advisable and to buy, hold and own and otherwise deal in open accounts, conditional sales contracts, commercial paper, bills of lading, warehouse receipts, bonds and securities, including personal property, leases, contracts, mortgages and choses in action of any and every kind, nature and description; to buy, sell, hold, take and receive by way of absolute or security title and deliver on consignment or in trust or under bailments, and otherwise deal in merchandise and personal property of any and every kind, nature and description, including the good will and rights of any business.
- (c) To purchase and own real estate of all types and characters; to subdivide real estate into lots and blocks; to improve and develop real estate; to build buildings, apartments, condominiums and structures thereon; to borrow money on and mortgage its real estate; and to do any and all things that a natural person might or could do, in dealing generally in the business of



buying and selling real estate; erecting structures and buildings of all types upon real estate; and borrowing money upon and mortgaging real estate.

- (d) To own, lease, rent, buy, sell, and generally deal in personally property of all types and character.
- (e) To subscribe for, purchase, or otherwise acquire, own, hold, invest in, sell, assign, transfer, exchange, pledge, mortgage, grant security interests in, or otherwise deal and trade in or with shares of stock, bonds, coupons, promissory notes, pledges, obligations, contracts, leases, evidences of debt, or securities of any company, corporation, or association, domestic or foreign.
- (f) To receive, collect, hold, and dispose of interest, dividends, and income of land and from any of the shares of stock, bonds, coupons, promissory notes, pledges, obligations, contracts, leases, evidences of debt, securities or other property held or owned by it.
- (g) To apply for, obtain, register, purchase, lease or by other means acquire, hold, own, use, develop, introduce, grant licenses in respect of, or otherwise dispose of Letters Patent of the United States or of any foreign country, Patents, Patented rights, licenses, privileges, inventions, improvements, formulas, secure, processes, copyrights, trademarks, and trade names, and pending applications therefore and renewals thereof and any interest therein which may relate to or be useful in connection with any business of the corporation, and to expand money in experimenting upon, testing, developing, and improving or seeking to improve the same.
- (h) To undertake and carry on any lawful business anywhere and generally to institute, enter into, carry on, assist, promote and participate in commercial, mercantile, industrial, financial, and other businesses, works, contracts, syndicates, underwriting, and other financial operations, and to act as brokers and financial agents of any individual, firm corporation trust, or association; and to aid in any manner any corporation, or in which this corporation is in anyway interested; and to merge or consolidate with any corporation in such manner as may be permitted by law.
- (i) To issue bonds, debentures, or obligations of this corporation of this corporation, and borrow money on a note or notes or this corporation for any of the objects or purposes of the corporation and to secure the same pledge, mortgage, deed, security interests, or trust or otherwise of any property, real or personal, of every kind and nature at any time by the corporation.
- (j) To purchase, hold, sell, and transfer the shares of its own capital stock, provided that shares of its own capital stock belonging to it shall not be voted upon directly or indirectly; and provided further that the rights of creditors shall not thereby be affected.
- (k) To do all and everything necessary, suitable, convenient, or proper for the accomplishment of any of the purposes of the attainment of any one or more of the objects herein enumerated, on incidental to the powers herein named, or which shall at any time appear conducive or expedient for the benefit of protection of the corporation, to the same extent and as fully as natural persons might or could do, with all the powers now or hereafter conferred under the Laws thereof.

The foregoing clauses shall be construed both as objects and powers; and it is hereby expressly provided that the foregoing enumeration of such specific powers shall not be held to limit or restrict in any manner the powers of the corporation.

Article IV Shares

The aggregate number of shares which the corporation shall have the authority to issue is one thousand (1000) shares of one dollar (\$1) par value, common stock, with identical rights and privileges, the transfer of which is restricted according to the Bylaws of the corporation.

Article V Initial Officers and/or Directors

The number of directors constituting the initial Board of Directors shall be two (2). Thereafter, the number of Directors shall be fixed in the manner provided in the By-laws, and may be increased or decreased from time to time by amendment to, or in the manner provided in the By-laws, but no decrease shall have the effect of shortening the term of any incumbent Directors.
