FIRST: The name of the corporation as currently filed with the Florida Department of State: VERTICAL INVENTORY SOLUTIONS, Inc.

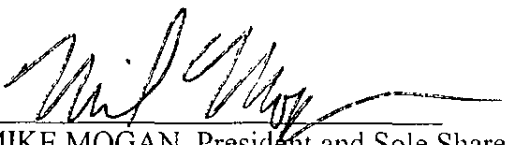
