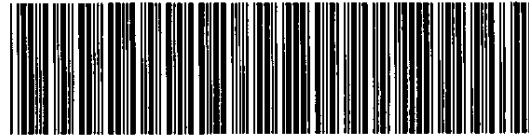

**ARTICLES OF INCORPORATION
OF
CREATIVE SOLUTIONS LEARNING ACADEMY, INC.**

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE ONE - NAME

The name of the corporation is: CREATIVE SOLUTIONS LEARNING ACADEMY, INC.

ARTICLE TWO - CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE THREE - PURPOSES

The general purposes for which the corporation is organized are:

1. To provide childcare services to children of our Florida Communities. This corporation is designed to improve learning, and to provide to our users a nurturing, and comfortable environment in compliance with the rules established under the Florida statutes for Childcare Services;

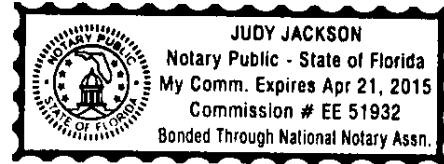
