The undersigned subscriber of these Articles of Incorporation, a natural person competent to contract, hereby shall form a corporation under the laws of the State of Florida.

ARTICLE I - CORPORATE NAME

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

- 1. Woudya, Inc. is organized exclusively for charitable purposes, including the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future code.
- 2. Woudya, Inc. is an on line forum that will allow individuals and businesses to post a request for donations of cash or services, and allow individuals and businesses to make donations in response to those requests. This will facilitate individuals and businesses with the ability to provide goods and services ready access to individuals and businesses that have a need for those goods and services.
- 3. Woudya, Inc. shall distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code of 1986, as amended.
- 4. Woudya, Inc. will not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code of 1986, as amended.

ARTICLE IV - RESTRICTIONS

- 1. No part of the net earnings of Woudya, Inc. shall be used for the benefit of, or distributed to its members, trustees, or officers, except that reasonable compensation for services rendered, and the furtherance of the purpose of Woudya, Inc.
- 2. No substantial part of the activities of Woudya, Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation. Woudya, Inc. also shall not participate in, or intervene in any political campaign on behalf of any candidate for political office.
- 3. Woudya, Inc. shall not carry on any activities not permitted to be carried on by an organization exempt from federal tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- 4. Woudya, Inc. will not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code of 1968, as amended.
- 5. Woudya, Inc. will not make any investments in such a manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1986, as amended.
- 6. Woudya, Inc. will not make any taxable expenditure as defined in Section 4945(d) of the Internal Revenue Code of 1986, as amended.

ARTICLE V - DISSOLUTION
