Effective September 30, 2013 and pursuant to the provisions of Sections 607.1007 and 607.1005 of the Florida Statutes, the undersigned Corporation adopts the following Restated and Amended Articles of Incorporation of Crevasse's Simple Cremations, Inc., which was originally incorporated on April 16, 2013 (Document Number: P13000034643), and which was issued the following Federal Employer Identification Number (FEIN): 46-2462854.

#### **ARTICLE I - Name**

The name of the corporation is: Crevasse's Simple Cremations, Inc.

# **ARTICLE II - Principal Office and Mailing Address**

This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
