## ARTICLES OF INCORPORATION

#### ARTICLE I - NAME

The name of the corporation is DiChiria Group, Inc., at 100 Rialto Place, Suite 759, Melbourne, FL 32901 (Principal Office of Registered Agent).

#### **ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

#### ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares".
