Shares of capital stock of this Corporation shall be issued initially to the following persons and in the amount set opposite their names:



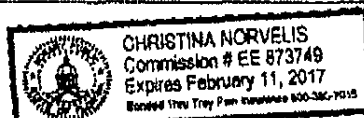


