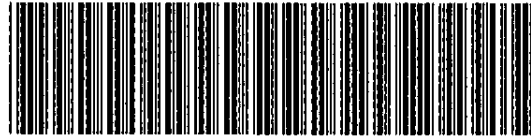

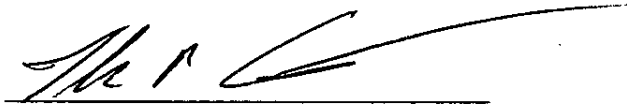

SAFE PRISON, INC.

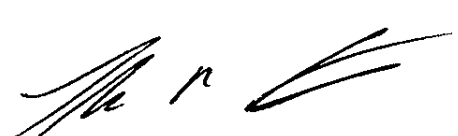
The principle place of business of this corporation shall be 4221 West Spruce Street, Unit 1210, Tampa, FL 33607.
