

ARTICLES OF AMENDMENT to ARTICLES OF INCORPORATION of DEER ISLAND GOLF AND LAKE CLUB, INC.

The Articles of Incorporation of Deer Island Golf and Lake Club, Inc., a Florida corporation, were filed with the Florida Secretary of State on April 26, 2013, under Document No. P13000037883.

1. The following provisions of the Articles of Incorporation are hereby amended in the following particulars:
