

In compliance with the requirements of F.S. Chapter 607, the undersigned does hereby as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I - CORPORATE NAME

The name of this corporation is INSIDEHIT, INC.

ARTICLE II - PRINCIPAL OFFICE
