# ARTICLES OF INCORPORATION PALM BEACH INDUSTRIAL PARK II, INC.

a Florida corporation

The undersigned, desiring to form a Florida profit corporation under 607 and/or 62% Florida Statutes (2012), do hereby adopt the following Articles of Incorporation:

- 1. Name. The name of this company shall be Palm Beach Industrial Park II, Inc.
- 2. Duration/Continuation. The period of this company's duration shall be perpetual, unless terminated by the unanimous written agreement of all shareholders or by the death, retirement resignation, expulsion, bankruptcy or dissolution of a shareholder or upon the occurrence of any other event which terminates the continued ownership of a shareholder, unless the business of the company is continued by the consent of all the remaining shareholders, or by amendment of these Articles of Incorporation providing for the continued existence of the company subsequent to the foregoing events.

- 5. Admission of Additional Shareholders; and Terms and Conditions of such Admissions. Additional shareholders may be admitted only upon the approval of the majority of the non-transferring shareholders of the Company upon the written application of such new shareholder, in the manner set forth in the Regulations of the Corporation.
  - 6. Right to Continue Business. The Corporation shall be perpetual.
- 7. Purpose of Business. 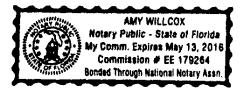
