**ARTICLES OF INCORPORATION
OF
SPEEDY ACCURATE TRANSCRIPTION, INC.**

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME AND ADDRESS

The name of the corporation shall be Speedy Accurate Transcription, Inc., (the "Corporation"). The address of the principal office of the Corporation shall be 8939 North Dale Mabry Highway, Tampa, Hillsborough County, Florida 33614, and the mailing address shall be the same.

ARTICLE II. CAPITAL STOCK


