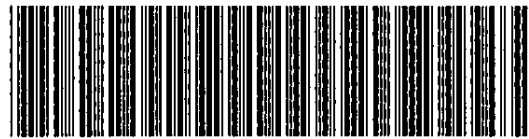

ARTICLE I - NAME, PRINCIPAL ADDRESS AND MAILING ADDRESS

The name of the Corporation shall be *fp3* PHOTOGRAPHY, INC. The principal and mailing address of the corporation shall be 1303 N. Armenia Ave., Tampa, FL 33607-5310.

ARTICLE II - CAPITAL STOCK
