### ARTICLES OF INCORPORATION

The undersigned, for the purposes of incorporating a corporation under the Florida Business Corporation Act, does hereby execute those Articles of Incorporation and does hereby certify as follows:

FIRST: The name of the corporation (hereinafter called the "Corporation") is Three Guys Roofing Inc. The principal place of business is 700 Uno Lago Drive #103, Juno Beach, Florida 33408.

SECOND: The address of the registered office of the Corporation in the State of Florida is 700 Uno Lago Drive #103, Juno Beach, Florida, Palm Beach County, Florida 33408, and the name of the registered agent of the Corporation in the State of Florida at such address is Shawn M. Wolfe.

<u>THIRD</u>: The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

<u>FOURTH</u>: The Corporation is authorized to issue one million (1,000,000) shares of Common Stock, par value \$0.01 per share.

FIFTH: The Corporation shall continue to exist perpetually.

SIXTH: Elections of directors need not be by written ballot unless the Bylaws of the Corporation shall so provide. Meetings of shareholders may be held within or outside the State of Florida, as the Bylaws may provide. The books of the Corporation may be kept (subject to any provision contained in the statutes) outside the state of Florida at such place or places as might be designated from time to time by the Board of Directors or in the Bylaws of the Corporation.

SEVENTH: The Corporation has three (3) directors initially. The names and addresses of the initial directors are Shawn M. Wolfe, 700 Uno Lago Drive #103, Juno Beach, Florida 33408, Wayne C. D'Angelo Sr., 357 Bunker Ranch Road, West Palm Beach, Florida 33405 and Wayne C. D'Angelo Jr., 357 Bunker Ranch Road, West Palm Beach, Florida 33405.

<u>EIGHTH</u>: A director of the Corporation shall, to the full extent permitted by the Florida Business Corporation Act as it now exists or as it may hereafter be amended, not be liable to the Corporation or its shareholders for monetary damages for breach of fiduciary duty as a director. Neither any amendment nor repeal of this Article EIGHTH, nor the adoption of any provision of these Articles of Incorporation inconsistent with this Article EIGHTH, shall eliminate or reduce the effect of this Article EIGHTH in respect of any matter occurring, or any cause of

action, suit or claim that, but for this Article EIGHTH, would accrue or arise, prior to such amendment, repeal or adoption of an inconsistent provision.

NINTH: The Corporation shall, to the fullest extent permitted by the Florida Business Corporation Act as amended from time to time, indemnify all persons whom it may indemnify pursuant thereto.
