

As you may recall from prior correspondence, I represent Universal Property & Casualty Insurance Company ("UPCIC") in a lawsuit against Universal P&C Ins. Inc. (document number P13000046513) in Miami-Dade County Court. The suit relates to Universal P&C Ins. Inc.'s misappropriation of UPCIC's name and corporate identity in order to misdirect and steal insurance premium payments from mortgage companies and their mortgagors, Florida homeowners.

On March 3, 2014, Miami-Dade County Court Judge Shelley Kravitz entered Judgment in favor of UPCIC and against Universal P&C Ins. Inc. A copy of the Judgment as signed by Judge Kravitz and recorded in the Official Records of Miami-Dade County (Bk. 29056, Pg. 3635) is enclosed.

The Judgment judicially dissolves Universal P&C Ins. Inc. Your Division previously administratively dissolved Universal P&C Ins. Inc. for its failure to comply with the Florida Business Corporation Act. The Judgment further asks the Division to include a copy of the Judgment on the Division's webpage relating to Universal P&C Ins. Inc. and to not reinstate Universal P&C Ins. Inc. absent further order of the Court.

The Court having reviewed the Motion and court file and being otherwise informed, it is hereby

ORDERED AND ADJUDGED, as follows:

- Plaintiffs' Motion for Default Judgment is GRANTED and this
 Judgment is entered thereon;
- 2. Defendant Universal P&C Ins. Inc. (Florida Division of Corporations document number P13000046513) is judicially dissolved;
- 3. The Florida Department of State Division of Corporations shall not reinstate Universal P&C Ins. Inc. absent future order of this court and shall include a copy of this Judgment in the Division's file on Universal P&C Ins. Inc. published

on the internet;

- 4. Defendant Universal P&C Ins. Inc. and its officers, directors, and other agents are permanently enjoined from contacting financial institutions purporting to represent UPCIC or otherwise indicating to any person in any context that there is any commercial relationship in any context between it and UPCIC;
- 5. Plaintiff shall recover from Defendant the damages suffered by UPCIC as the result of Defendant's unauthorized use of UPCIC's name, likeness, reputation, and OIR licensure status;
- 6. Plaintiff shall recover from Defendant the attorney's fees and costs incurred by UPCIC, pursuant to 15 U.S.C. § 1117, § 772.104, Fla. Stat., § 817.41(6), Fla. Stat., and §57.041, Fla. Stat.; and
- 7. Jurisdiction of this case is retained to determine the amounts recoverable by Plaintiffs pursuant to paragraphs 5 and 6 above if the parties are unable to agree on such amounts and as otherwise required to enforce this Judgment.
