Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, WELLDYNE, INC., a Florida corporation, adopts the following Amendment to its Articles of Incorporation:

1. The Articles of Incorporation of WELLDYNE, INC. were duly filed with the Florida Secretary of State on June 3, 2013, and assigned Document Number P13000048182. WELLDYNE, INC. was originally incorporated as a Colorado corporation on December 22, 1994 but was domesticated in Florida on June 3, 2013.

2. Article I of the Articles of Incorporation of WELLDYNE, INC. is hereby amended to read as follows:

"ARTICLE I - NAME, PRINCIPAL OFFICE AND MAILING ADDRESS

The name of the Corporation is HILLCOUR, INC. The Corporation's principal office is 3000 Bayport Drive, Suite 745, Tampa, Florida 33607, and its mailing address is the same."


