ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF COFE WESTERN WAY CORPORATION

Pursuant to the provision of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Cofe Western Way Corporation (the "Corporation").
- 2. The following amendments of the Articles of Incorporation were agreed to and adopted by the incorporator of the Corporation on the 18th day of September, 2013, pursuant to Section 607.1005 of the Act.
