ARTICLE I

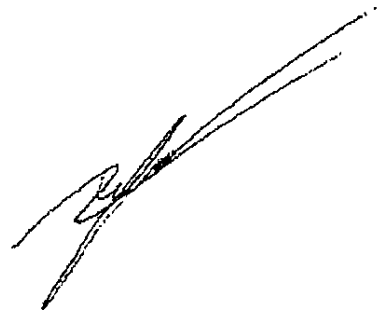

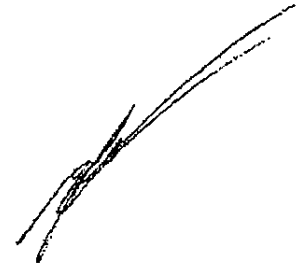

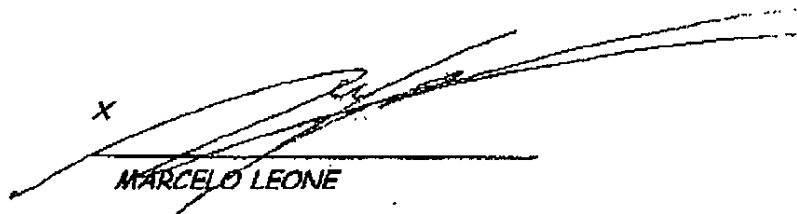
